The CGA conducts the State Junior Championships and state travel teams were identified to compete in Junior Americas Cup and Pacific Coast Am competitions.

CGA performs course ratings and measurements and monitors member clubs' compliance with USGA handicap certification and licensing requirements in Colorado and Wyoming. The Solich Caddie & Leadership Academy, LLC (the Academy) was formed in 2012 for the purpose of educating and training teenagers on how to be a caddie and to use caddying and the game of golf as a platform to teach them how to succeed in life. In 2025, the Academy had 95 caddies in five golf course locations. The Academy is 100% owned by CGA.

The Broadmoor Caddie & Leadership Academy mission is to develop and operate a world-class caddie program that provides outstanding customer service and an enhanced playing experience for members and resort guests at The Broadmoor. Through selective and targeted recruiting, attract the highest quality young men and women for a unique growth experience through caddying, leadership, and life skill development, while enabling them to pursue scholarship opportunities, such as the Evans Scholarship. In 2025, the Academy had 45 caddies. The Academy is 100% owned by CGA.

The CGA conducts golf-in-schools classroom programming for students grades 4-12 at public, private, and charter schools around the Denver-Metro area. These sessions culminate with a field trip to CommonGround GC for a half day of on-course golf programming. This is at no cost to the schools.

The CGA partners with schools to provide golf activities on schoolwide field days. This is at no cost to the schools.

The CGA partners with local non-profit organizations like Big Brothers Big Sisters, Special Olympics, Adaptive Recreation for Childhood Health and more to provide introductory golf opportunities and experiences at CommonGround GC and other courses. This is done at no cost to partner organizations.

The CGA serves as a Site Director for LPGA/USGA Girls Golf programming at CommonGround GC, administering golf activities specifically tailored to girls.

The CGA administers the USNDP's State Team Program through Team Colorado. 16 of the most elite junior golfers received training and benefits through this CGA funded program.

The CGA administers Youth on Course in Colorado. In 2025 there were 11,245 Youth on Course members who played 37,578 rounds on 41 participating courses. The CGA subsidized over \$238,000 back to participating courses.
