The CGA also supports the Colorado Open and Women's Colorado Open events at Green Valley Ranch GC, the Rocky Mountain Open, and CHSAA Championships.

The CGA conducts the State Junior Championships involving 494 entrants and state travel teams were identified to compete in Junior Americas Cup competitions.
