# CGA Four-Ball Championship

August 28 - 30, 2020  
Legacy Ridge Golf Course



## CONDITIONS OF COMPETITION

**Format:** Fifty-four holes of Four-Ball stroke play.

**Tees:** White, CGA tee markers.

**Recording of Scores:** All scores for each side must be individually identifiable.

**Tie:** A tie for the championship will be resolved by a sudden death playoff.

## LOCAL RULES

**Out of Bounds:** Defined by white stakes/posts, white lines, property fencing at base level and/or the inside edge (course side) of the concrete curb on any public road or sidewalk (when present). If a ball crosses a public road, the ball is deemed to be *out of bounds* even if it lies on another part of the *course*.

**Internal Out of Bounds:** The white stakes between holes #5 & #6 are *boundary objects* and define *out of bounds* for hole #6 only. For the play of hole #5, the white stakes are *immovable obstructions*. Players may not play down #5 fairway during play of hole #6.

**Obstructions:** Gravel cart paths and artificially surfaced paths are *obstructions*. The dirt cart path runoffs on #5 are part of the *obstruction*.

**Ground Under Repair:** Defined by white lines. Cultivated flowerbeds and active nurseries are *no play zones* and are *ground under repair*, whether or not marked, and relief is mandatory. The hay netting with the leveling project left of the cart path on hole #16.

**Mulch and Wood Chips:** Are *loose impediments*.

**Drop Zones:** For a ball played into the penalty area on hole #11 and for a ball played into the penalty area on hole #13.

**Environmentally Sensitive Areas (No Play Zones):** Denoted by green topped penalty area stakes and/or posted signs and defined by the lien on the ground. When a ball is in the *no play zone* within the *penalty area*, the ball must not be played as it lies and relief must be taken from interference by the *no play zone* under Rule 17.1e

When the ball lies outside the ESA and in the general area, interference by an ESA occurs when anything within the ESA interferes with the player's stance or the area of intended swing. If interference exists, the player must take relief as follows:

(a) General Area: If the ball lies in the general area, the point on the course nearest to where the ball lies must be determined that (a) is not nearer the hole, (b) avoids interference by the ESA and (c) is not in a penalty area, bunker or on a putting green. The player must drop a ball, without penalty, within one club-length of the point so determined on a part of the course that fulfils (a), (b) and (c) above. **If a ball is in a bunker, the above procedure must be followed except that a ball must be dropped in the bunker.**

**Damage to the Putting Green:** For the damage due to hydrolic leak (parallel lines) on the putting green, a ball that comes to rest in or on the damage may be placed at the nearest spot not nearer the hole that avoids the situation. There is no line of play relief available.

**Animal Holes:** Any hole dug in the ground by an animal and includes the loose material the animal dug out of the hole, any worn-down track or trail leading into the hole, and any area on the ground pushed up or altered as a result of the animal digging the hole.
