

2020 CGA Rules of Golf Test

	does not find the ball after a three-minute search. The player uses a drop zone that is
	designated for a ball known or virtually certain to be in a penalty area and places a ball there
	and plays out the hole in 4 more strokes. The Committee found there to be no serious breach or
